I _____ the parent/guardian of _____ am registering my child for enrollment at All Cubs, LLC. I agree to pay the above stated tuition monthly. If, payment is made by check and a bounced check is received a processing fee will be charged back to the family. If more than 2 checks are returned with insufficient funds check payment will no longer be accepted. The tuition cost includes all materials including: breakfast, snacks and 50% of Smart Lunches choices. Smart Lunches is not mandatory, but parents/guardian will be responsible to provide lunch if Smart Lunches is not selected. Children's yoga, music, art and Angel Watch are also included within the tuition fee. One-time registration is collected at the start of enrollment. Parents/guardians are responsible for turning in all necessary paperwork to the center before any child can start. The center is closed for 8 days during the year; New Year's Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving; Day after Thanksgiving; Christmas day and the day after Christmas. Dependent on the calendar year if, one of these days fall on a Saturday the center will be closed on the Saturday, if one of these days fall on a Sunday we will be closed on the Monday after. The center will be closing early at 3PM, on Thanksgiving Eve and New Year's Eve. Children's sick days, weather-related emergencies and personal days cannot be accommodated and tuition must be paid in full monthly. Each family is entitled to take two weeks of vacation each school year from November through September and tuition will be waived during this time. Family vacation must be notified to All Cubs, LLC the month prior to the vacation and your child's placement will be held for two weeks; if the family vacation will be longer than 2 weeks special arrangements will have to be made to keep your child's placement or you may be able to reenroll upon return if there is any space available. If starting or leaving the center in the middle of the month tuition will be pro-rated. If, you start the month at the center and prior arraignments were not made you are responsible for the entire months tuition. Even if you pay weekly, semi-weekly or are late with your payment. Tuition must be paid on time; **monthly tuition** is due on the 1st of every month. \$25 late fee incurred if received after the 3rd of the month. **Semi-monthly** Tuition is due on the 1st and 15th of each month, \$25 late fee incurred if received after the 3rd and the 17th of the month, **Weekly Tuition** is due every Monday each week, \$15 late fee incurred if received after Tuesday each week. Late fees for tuition payment will be incurred on the day specified and the same amount will be added every Monday following that the payment is not made.
